

ORDINANCE NO. 20233

AN ORDINANCE introduced by City Manager Brent Trout, allowing and approving City expenditures for the period of November 2, 2019 through November 29, 2019, and enumerating said expenditures herein.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF TOPEKA, KANSAS:

Section 1. All expenditures made or authorized to be made by issuance of checks or electronic transfers as enumerated herein, are in accordance with City of Topeka Resolution No. 7607.
