12	<u>Section 1</u> . That the following described land, meeting the conditions for annexation
13	prescribed in K.S.A. 12-520(a)(7), is hereby annexed and made a part of the City of Topeka, Kansas:
14	A TRACT OF LAND IN GOVERNMENT LOT 4 AND GOVERNMENT LOT 5 SITUATED IN
15	THE SOUTHEAST QUARTER OF FRACTIONAL SECTION 14, TOWNSHIP 11 SOUTH,
16	RANGE 15 EAST OF THE $6^{TH}$ P.M. IN SHAWNEE COUNTY, KANSAS, DESCRIBED AS
17	FOLLOWS: BEGINNING AT THE NORTHEAST CORNER OF SAID GOVERNMENT LOT 5;
18	THENCE ON AN ASSUMED BEARING OF SOUTH 01 DEGREE 19 MINUTES 56 SECONDS
19	EAST, 1272.43 FEET TO A LINE WHICH IS 150 FEET NORTH OF THE CENTERLINE OF
20	HIGHWAY US-24; THENCE SOUTH 87 DEGREES 58 MINUTES 07 SECONDS WEST,
