

ORDINANCE NO. 20432

AN ORDINANCE introduced by Acting City Manager Richard U. Nienstedt, allowing and approving City expenditures for the period of April 29, 2023 to May 26, 2023 and enumerating said expenditures herein.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF TOPEKA, KANSAS:

Section 1. All expenditures made or authorized to be made by issuance of checks or electronic transfers as enumerated herein, are in accordance with City of Topeka Resolution No. 7607.
