6 7	BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF TOPEKA, KANSAS:
8	Section 1. That Section 3 of Ordinance No. 20426, to be codified at TMC
9	2.260.030, Board of trustees, of The Code of the City of Topeka, Kansas, is hereby
10	amended to read as follows:
11	Board of trustees; appointment, terms.
12	(a) The Board shall consist of five members who reside within the boundaries
13	of the City or Shawnee County. One member shall be a member of a neighborhood
14	improvement association established pursuant to TMC 2.25.050; one member shall be
15	an employee of the City designated by the city manager; and one member shall be a
16	City Council member.
17	(b) Board members shall be appointed by the Mayor and approved by the City
18	Council. Board members' terms shall commence upon approval of the appointment by
19	the City Council and terminate on the earlier of (1) December 31, 2026; or (2) on the
20	date the Bank is dissolved, by ordinance, pursuant to K.S.A. 12-5902(d) and
21	amendments thereto.
22	(c) Terms of office shall be as follows: (1) August 1, 2023 to December 31
23	2024; (2) January 1, 2025 to December 31, 2025; (3) January 1, 2026 to December 31
24	<u>2026.</u>
25	Upon expiration of a term the position shall remain vacant until a successor is
26	appointed. Vacancies shall be filled for an unexpired term in the same manner as the

27	original appointments were made.
28	Section 2. That original Section 3 of Ordinance No. 20426, to be codified at
29	TMC 2.260.030 of The Code of the City of Topeka, Kansas, is hereby specifically
30	repealed.
31	Section 3. This ordinance shall take effect and be in force from and after its
32	passage, approval and publication in the official City newspaper.
33	Section 4. This ordinance shall supersede all ordinances, resolutions or rules,
34	or portions thereof, which are in conflict with the provisions of this ordinance.
35	Section 5. Should any section, clause or phrase of this ordinance be declared
36	invalid by a court of competent jurisdiction, the same shall not affect the validity of this
37	ordinance as a whole, or any part thereof, other than the part so declared to be invalid.
