4 **ORDINANCE NO. 19113**

6 AN ORDINANCE introduced by Councilmember John Alcala authorizing the sale,  
7 consumption and possession of alcoholic liquor as part of the Fiesta  
8 Mexicana at specified locations and times.

10 NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF  
11 TOPEKA, KANSAS:

12 Section 1. a) Authorization is given to barricade a portion of Atchison Avenue  
13 between NE Chandler and NE Lake Streets and NE Chandler Street between Greeley  
14 Street and Atchison Avenue from July 14, 2008 through July 19, 2008, between the hours  
15 of 5:00 p.m. and 12:00 p.m. midnight. Attendance to the celebration is open to the public  
16 between these hours. Licensed retailers may sell non-alcoholic commodities or food  
17 between the hours of 5:00 p.m. and 12:00 p.m. midnight from July 14, 2008 through July  
18 19, 2008.

19 b) The barricaded portion of Atchison Avenue between NE Chandler and NE  
20 Lake Streets and NE Chandler Street between Greeley Street and Atchison Avenue shall  
21 be temporarily removed from the City's right-of-way and the provisions of K.S.A. 41-719.  
22 Vendors holding the appropriate license from the State of Kansas to sell alcoholic liquor  
23 may in accordance with all applicable state laws and municipal ordinances sell alcoholic  
24 liquor in the specific area designated by the division of Alcohol Beverage Control within the  
25 barricaded portion of Atchison Avenue between NE Chandler and NE Lake Streets and NE  
26 Chandler Street between Greeley Street and Atchison Avenue between the hours of 5:00  
27 p.m. and 12:00 p.m. midnight from July 14, 2008 through July 19, 2008.

c) Event attendees may buy, possess and consume alcoholic beverages in the specific area designated by the division of Alcohol Beverage Control within the barricaded portion of Atchison Avenue between NE Chandler and NE Lake Streets and NE Chandler Street between Greeley Street and Atchison Avenue between the hours of 5:00 p.m. and 12:00 p.m. midnight on from July 14, 2008 through July 19, 2008.

Section 2. This Ordinance shall be null and void on June 20, 2008.

Section 3. This Ordinance shall take effect and be in force after its passage, approval and publication in the official city newspaper.
