8 9	BE IT ORDAINED BY THE COUNCIL OF THE CITY OF TOPEKA, KANSAS:
10 11	Section 1. That section 2-116, Oath, of The Code of the City of Topeka,
12	Kansas, is hereby amended to read as follows:
13	Oath.
14	(a) All officers of the city, whether elected or appointed, and each person to
15	be employed by the city shall, before entering upon the duties of their respective offices,
16	appointment or employment, take and subscribe an oath or affirmation, as follows:
17	"I do solemnly swear (or affirm, as the case may be) that I will support the Constitution
18	of the United States of America and the Constitution of the State of Kansas and
19	faithfully discharge the duties of (here enter name of office or
20	employment). So help me God."
21	(b) Oaths or affirmations required under this division shall be administered
22	before such officers and in the manner prescribed by K.S.A. 54-101, 54-102 and 54-
23	103.
24	(c) All officers and employees required by law to take and subscribe or file
25	any oath or affirmation shall be supplied the necessary forms for this purpose at the
26	expense of the city and, upon taking and subscribing or signing any such oath or
27	affirmation, such completed original or copies of forms for city employees oaths shall be
28	filed with the city personnel division human resources department. Completed original
29	or copies of forms of oaths for elected and appointed officers shall be filed with the city

30	<u>clerk.</u>
31	(d) The city treasurer shall not disburse any funds in payment for services to
32	any officer or employee of the city until the original oath or affirmation provided for in
33	this division shall have been duly subscribed and the original or a copy is filed with the
34	city by such officer or employee.
35	Section 2. That section 90-28, Commission, badge, oath, of The Code of the
36	City of Topeka, Kansas, is hereby amended to read as follows:
37	Commission, badge, oath.
38	Each police officer appointed under this article shall be issued a commission,
39	signed by the city manager and attested by the city clerk, and a badge of office. Each
10	such officer and member of the department shall, before entering upon the duties of the
11	office, take and subscribe an oath of office and such other oath as may be required by
12	law, and such original or copy of the oath shall be filed with the city auditorhuman
13	resources department.
14	Section 3. That original sections 2-116 and 90-28 of The Code of the City of
15	Topeka, Kansas, is hereby specifically repealed.
16	Section 4. This ordinance shall take effect and be in force from and after its
17	passage, approval and publication in the official City newspaper.
