## ORDINANCE NO. 19350

AN ORDINANCE introduced by City Manager Norton N. Bonaparte, Jr., authorizing Improvement Project No. T-841010.00 (HTE #843600), which provides for city wide maintenance and improvements on existing streets, as more specifically described herein, and authorizing Improvement Project No. T-841012.00 (HTE #843620), which provides for the design of the projects in the 2011 Street Maintenance Program.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF TOPEKA, KANSAS:

Section 1. That it hereby deems advisable and necessary Improvement Project No. T-841010.00 (HTE #843600) and also hereby authorizes that the public improvement be made as follows:

A. GENERAL NATURE OF IMPROVEMENTS:

1. 2010 Project Construction, Project No. T-841010.00:

This project will provide maintenance and improvements to existing city streets, curbs, gutters, sidewalks, alleys, and street lighting. Maintenance and improvements will be limited to elements which are already in place and in need of maintenance, repair, or replacement, as determined by the engineer. The project locations include the following:

- Gordon from Buchanan to Quincy
- 12th St. from Gage to Huntoon (Seabrook Ave.)
- 37th St. from Adams to West Edge Road
- 6th St. from Branner Trwy. To Swygart St.
- 10th St. from Gage to Republican (just East of California)
- Branner Trwy. & Adams St. from 10th St. to 29th St.
- SW Lane St. from Huntoon to 6th St.
- Washburn from Huntoon to 10th St.
- Huntoon from Washburn to Buchanan
- 29th St. from Fairlawn to Burlingame
- 29th St. from Swygart to KTA Bridge
- 6th St. from Orchard to Topeka Blvd.
- 21st St. from Wanamaker to I-470
- Topeka Blvd. from 29th to 37<sup>th</sup>
- 29th St. from Topeka Blvd to Kansas Ave.
