3 **ORDINANCE NO. 19417**

5 AN ORDINANCE introduced Councilmember John Alcala authorizing the sale,  
6 consumption and possession of alcoholic liquor at a specified  
7 locations and times for the 2010 Germanfest celebration on June 5  
8 and 6, 2010, to be held at Sacred Heart-St. Joseph Parish.

10 BE IT ORDAINED BY THE COUNCIL OF THE CITY OF TOPEKA, KANSAS, that:

11 Section 1. Authorization is given to barricade certain portions of Freeman Street,  
12 Rowley Street, Greeley Street and an east-west alley on the south side of the church hall  
13 as designated on the map attached hereto as Exhibit A (the "Designated Barricaded Area")  
14 on June 5, 2010, between the hours of 4:00 p.m. and 11:00 p.m. and on June 6, 2010,  
15 between the hours of 10:00 a.m. and 6:00 p.m. Attendance to the celebration is open to  
16 the public between these hours.

17 Section 2. The Designated Barricaded Area shall be temporarily removed from  
18 the City's right-of-way and the provisions of K.S.A. 41-719. Vendors holding the  
19 appropriate license from the State of Kansas to sell alcoholic liquor may in accordance with  
20 all applicable state laws and municipal ordinances sell alcoholic liquor in the specific area  
21 designated by the division of Alcohol Beverage Control within the Designated Barricaded  
22 Area of Freeman Street, Rowley Street, Greeley Street and an east-west alley on the south  
23 side of the church hall on June 5, 2010, between the hours of 4:00 p.m. and 11:00 p.m. and  
24 on June 6, 2010, between the hours of 10:00 a.m. and 6:00 p.m.

25 Section 3. Event attendees may buy, possess and consume alcoholic beverages  
26 in the specific area designated by the division of Alcohol Beverage Control within the  
27 Designated Barricaded Areas of Freeman Street, Rowley Street, Greeley Street and an  
28 east-west alley on the south side of the church hall on June 5, 2010, between the hours of

29 4:00 p.m. and 11:00 p.m. and on June 6, 2010, between the hours of 10:00 a.m. and 6:00  
30 p.m.

31 Section 2. This Ordinance shall be null and void on June 7, 2010.

32 Section 3. This Ordinance shall take effect and be in force after its passage,  
33 approval and publication in the official city newspaper.

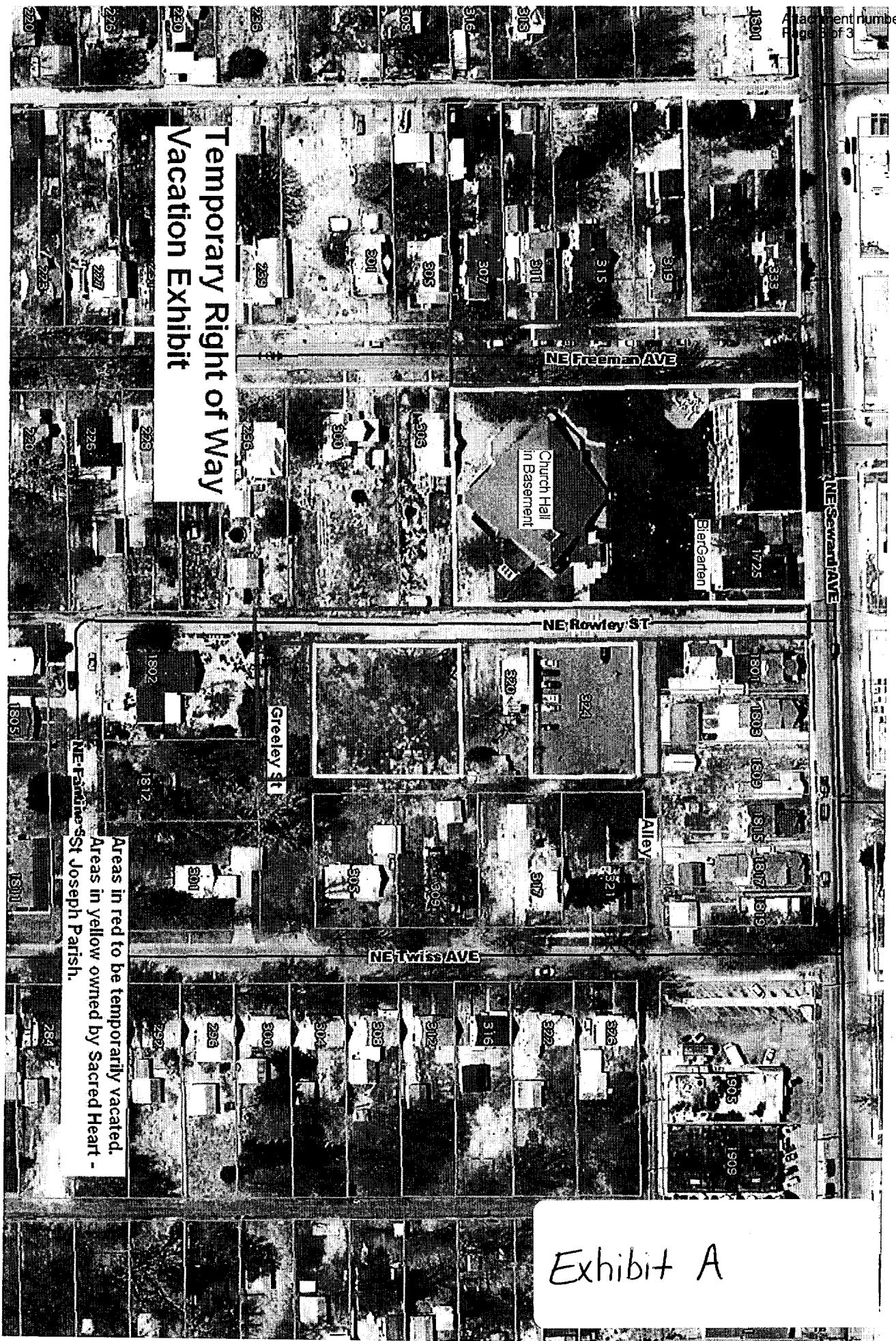
