4 **ORDINANCE NO. 19424**
5

6 AN ORDINANCE introduced by City Manager Norton N. Bonaparte, Jr., amending the
7 project budget and authorizing as amended Street Improvement
8 Project No. 70114-03 which provides for widening Gage Boulevard
9 from 10th to 12th Streets, as more specifically described herein,
10 pursuant to Section A12-1 of the Code of the City of Topeka, and
11 repealing City of Topeka Ordinance No. 19204.

13 WHEREAS, the Council of the City of Topeka adopted Ordinance No. 18956, which
14 authorized Street Improvement Project No. 70114-03 with an original project budget of one
15 hundred forty eight thousand dollars (\$148,000.00) for the design and acquisition of right-
16 of-way; and

17 WHEREAS, the Council adopted Ordinance No. 19204, which amended the scope
18 of the project and increased the project budget to one million one hundred eighty-eight
19 thousand dollars (\$1,188,000.00) in order to include cost of construction; and

20 WHEREAS, the Kansas Department of Transportation has increased the federal
21 participation of this project from eight hundred thousand dollars (\$800,000.00) to nine
22 hundred fifty thousand dollars (\$950,000.00) and it is necessary to amend the budget to
23 include the additional one hundred fifty thousand dollars (\$150,000.00) and authorize the
24 use of these funds.

25 NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF
26 TOPEKA, KANSAS:

27 Section 1. That it is hereby deemed advisable and necessary and is also hereby
28 authorized pursuant to Section A12-1 of the Code of the City of Topeka that the following
29 public improvement be made:

30 A. GENERAL NATURE OF IMPROVEMENT:

32 To widen SW Gage Boulevard from 10th to 12th Streets to provide a center
33 two-way left turn lane.
