AN ORDINANCE

introduced by City Manager Norton N. Bonaparte, Jr., amending the project budget and authorizing as amended Improvement Project No. T-291002.00 (HTE #291120) for replacement of Northland I Pump Station approving cost estimates of the proposed improvements, and doing all other things necessary and incidental thereto, and authorizing the publication of the Notice of Intention of the governing body of the City of Topeka, Kansas, to issue and sell revenue bonds of said City to make such improvements which constitutes improvements to the municipally owned water, water pollution control. and stormwater utility system of the City of Topeka, Shawnee County, Kansas, pursuant to K.S.A. 10-101 and 10-1201, et seq., and all amendments thereto, authorizing issuance of general obligation bonds to pay the costs of the project which further constitutes a general improvement to the City's sanitary and/or stormwater and sewage disposal system pursuant to City of Topeka Code §A12-1, and authorizing the borrowing of funds from the Kansas Department of Health and Environment State Revolving Loan Fund to pay the cost thereof and specifically repealing those sections of City of Topeka Ordinance No. 19172 in conflict with this Ordinance.

WHEREAS, the City is a municipality as defined by K.S.A. 10-101 and 10-1201 *et seq.* and all amendments thereto; and

WHEREAS, the City is authorized by the laws of the State of Kansas to issue and sell revenue bonds of the City for the improvement of its water, water pollution control, and stormwater utility system (the "System") pursuant to K.S.A. 10-1201 *et seq.* and all amendments thereto; and

WHEREAS, it is deemed by the governing body of the City to be necessary and advisable that the City to improve its System by replacement of Northland I Pump Station; and

WHEREAS, it is found by the governing body that such Project will not cause a duplication of existing utility service furnished by a private utility; and

WHEREAS, the City of Topeka, Shawnee County, Kansas, is authorized pursuant to
City of Topeka Code §A12-1, to issue general obligation bonds for the purposes of paying
for improvement, repair or extension to the City's waterworks system and sanitary and
stormwater sewage disposal system; and

WHEREAS, the City desires to issue and sell revenue bonds and/or general obligation bonds of the City and/or to borrow funds from the Kansas Department of Health and Environment (KDHE) State Revolving Loan Fund to fund the cost of the improvements or any combination thereof, and

WHEREAS, Ordinance No. 19172, passed and approved on October 7, 2008, estimated total cost of the improvements to be approximately seven hundred fifty thousand dollars (\$750,000.00); however, the original estimate was based on a replacement that was determined not to be feasible and, thus, the project budget needs to be revised and amended.

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF TOPEKA, KANSAS:

Section 1. That the estimates of costs of the Project as contained in the project budget in the amount of one million four hundred forty-seven thousand one hundred thirtyone million six hundred twenty thousand seven hundred eighty-six dollars (\$1,447,130.00\$1,620,786.00) which are set out in the project budget attached hereto and on file in the office of the City Clerk of said City, be and the same are hereby approved.

<u>Section 2</u>. That the general nature of the Project is as follows:

The new pump station will be construction approximately 1000 feet to the north and east of the existing location. This location will also allow for future expansion needs

associated with the recent increased development in the area. The design includes a new 1270 feet of 8" force main that will convey the waste up and over the Soldier Creek Levees as required by the current Army Corps of Engineers design guidelines. The alternate crossing would allow for the abandonment of the over fifty year old 6" existing force main having an alignment through the Soldier Creek Levees.

Section 3. That notice be given by the governing body of the City of its intention to complete the Project in accordance with the plans, specifications and cost estimates and to sell revenue bonds and/or general obligation bonds of the City and/or to borrow funds from the Kansas Department of Health and Environment (KDHE) State Revolving Loan Fund in a total amount not exceeding ene million four hundred forty-seven thousand one hundred thirtyone million six hundred twenty thousand seven hundred eighty-six dollars (\$1,447,130.00\$1.620,786.00) to pay the cost thereof. Such notice shall be signed by the Mayor and attested by the City Clerk and shall be published in the official City newspaper. Such notice shall describe the nature of the proposed improvements and shall state the amount of revenue and/or general obligation bonds proposed to be issued and/or KDHE loan funds to be borrowed, or any combination thereof for the payment of the cost of the project and otherwise, the notice shall be in the form as provided by law.

Section 4. That unless written protests against such proposed improvements signed by not less than twenty percent (20%) of the qualified electors of the City are filed with the City Clerk within fifteen (15) days after publication of the notice herein authorized the City both reasonably expects and intends to finance the costs as hereinbefore described from the proceeds of revenue bonds and/or general obligation bonds and/or KDHE loan funds or any combination thereof, payable from the rates, fees and charges of
