## **ORDINANCE NO. 19541**

AN ORDINANCE

introduced by City Manager Norton N. Bonaparte, Jr., amending the "District Map" referred to and made a part of the Zoning Ordinances by Section 18.50.050 of the Topeka Municipal Code (TMC), by providing for certain changes in zoning on property within the Central Highland Park neighborhood from "M-1" Two-Family Dwelling District, "M-2" Multiple-Family Dwelling District, and "C-2" Commercial District ALL TO "R-2" Single-Family Dwelling District. (Z11/1) (Council District Nos. 3 & 4).

BE IT ORDAINED by the Governing Body of the City of Topeka, Kansas, on this 22<sup>nd</sup>

day of March, 2011, as follows:

Section 1. That the "District Map" referred to and made a part of the Zoning Ordinances by Section 18.50.050 of the Topeka Municipal Code (TMC), be, and the same is hereby amended, by classifying the following described property:

Two districts in the Southwest Quarter of Section 5, and four districts in Section 8, all of which are in Township 12 South, Range 16 east of the 6<sup>th</sup> P.M., in the City of Topeka, Shawnee County, Kansas, said districts are composed of platted lots, the descriptions of said districts are:
