14	and SW Jackson Street from the south side of 8 th Avenue to the alley behind The Office
15	and The Celtic Fox on July 8, 2011, between the hours of 4:00 p.m. and 11:59 p.m., and on
16	July 9, 2011, between the hours of 11:00 a.m. and 11:59 p.m. Attendance to the
17	celebration is open to the public between these hours.
18	Section 2. The barricaded portion of SW 8 th Avenue from the west side of Kansas
19	Avenue to the west side of the intersection with SW Jackson Street and SW Jackson Street
20	from the south side of 8 th Avenue to the alley behind The Office and The Celtic Fox shall be
21	temporarily removed from the City's right-of-way and exempt from the provisions of K.S.A.

41-719(c). Vendors holding the appropriate license from the State of Kansas to sell alcoholic liquor may in accordance with all applicable state laws and municipal ordinances sell alcoholic liquor in the specific area designated by the division of Alcohol Beverage Control within the barricaded portion of SW 8th Avenue from the west side of Kansas Avenue to the west side of the intersection with SW Jackson Street and SW Jackson Street

from the south side of 8th Avenue to the alley behind The Office and The Celtic Fox on July

28	8, 2011, between the hours of 4:00 p.m. and 11:59 p.m., and on July 9, 2011, between the
29	hours of 11:00 a.m. and 11:59 p.m.
30	Section 3. Event attendees may buy, possess and consume alcoholic beverages
31	in the specific area designated by the division of Alcohol Beverage Control within the
32	barricaded portion of SW 8 th Avenue from the west side of Kansas Avenue to the west side
33	of the intersection with SW Jackson Street and SW Jackson Street from the south side of
34	8 th Avenue to the alley behind The Office and The Celtic Fox on July 8, 2011, between the
35	hours of 4:00 p.m. and 11:59 p.m., and on July 9, 2011, between the hours of 11:00 a.m.
36	and 11:59 p.m.
37	Section 4. In the case of cancellation of this event on July 8 and 9 due to rain, the
38	event will be held August 5 & 6 and the provisions set forth in Sections 1, 2 and 3 above,
39	shall not be applicable on July 8 and July 9, 2011, but instead shall be applicable on August
40	5, 2011, between the hours of 4:00 p.m. and 11:59 p.m., and on August 6, 2011, between
41	the hours of 11:00 a.m. and 11:59 p.m.
42	Section 5. This Ordinance shall take effect and be in force after its passage,
43	approval and publication in the official city newspaper.
