3 **ORDINANCE NO. 19567**

5 AN ORDINANCE introduced Councilmember Karen Hiller authorizing the sale,
6 consumption and possession of alcoholic liquor at a specified
7 locations and times for the Downtown Summer Jam on July 8 and 9,
8 2011, to be held by The Office and the Celtic Fox.

10 BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF TOPEKA,
11 KANSAS, that:

12 Section 1. Authorization is given to barricade a portion of SW 8th Avenue from the
13 west side of Kansas Avenue to the west side of the intersection with SW Jackson Street
14 and SW Jackson Street from the south side of 8th Avenue to the alley behind The Office
15 and The Celtic Fox on July 8, 2011, between the hours of 4:00 p.m. and 11:59 p.m., and on
16 July 9, 2011, between the hours of 11:00 a.m. and 11:59 p.m. Attendance to the
17 celebration is open to the public between these hours.

18 Section 2. The barricaded portion of SW 8th Avenue from the west side of Kansas
19 Avenue to the west side of the intersection with SW Jackson Street and SW Jackson Street
20 from the south side of 8th Avenue to the alley behind The Office and The Celtic Fox shall be
21 temporarily removed from the City's right-of-way and exempt from the provisions of K.S.A.
22 41-719(c). Vendors holding the appropriate license from the State of Kansas to sell
23 alcoholic liquor may in accordance with all applicable state laws and municipal ordinances
24 sell alcoholic liquor in the specific area designated by the division of Alcohol Beverage
25 Control within the barricaded portion of SW 8th Avenue from the west side of Kansas
26 Avenue to the west side of the intersection with SW Jackson Street and SW Jackson Street
27 from the south side of 8th Avenue to the alley behind The Office and The Celtic Fox on July

8, 2011, between the hours of 4:00 p.m. and 11:59 p.m., and on July 9, 2011, between the hours of 11:00 a.m. and 11:59 p.m.

Section 3. Event attendees may buy, possess and consume alcoholic beverages in the specific area designated by the division of Alcohol Beverage Control within the barricaded portion of SW 8th Avenue from the west side of Kansas Avenue to the west side of the intersection with SW Jackson Street and SW Jackson Street from the south side of 8th Avenue to the alley behind The Office and The Celtic Fox on July 8, 2011, between the hours of 4:00 p.m. and 11:59 p.m., and on July 9, 2011, between the hours of 11:00 a.m. and 11:59 p.m.

Section 4. In the case of cancellation of this event on July 8 and 9 due to rain, the event will be held August 5 & 6 and the provisions set forth in Sections 1, 2 and 3 above, shall not be applicable on July 8 and July 9, 2011, but instead shall be applicable on August 5, 2011, between the hours of 4:00 p.m. and 11:59 p.m., and on August 6, 2011, between the hours of 11:00 a.m. and 11:59 p.m.

Section 5. This Ordinance shall take effect and be in force after its passage, approval and publication in the official city newspaper.
