#### **ORDINANCE NO. 19614**

 AN ORDINANCE

introduced by City Manager Norton N. Bonaparte, Jr., apportioning and levying a special assessment on certain lots and pieces of ground in the City of Topeka, Shawnee County, Kansas, in the area of the Rockfire at the Lake and East Lake Shawnee Estates subdivisions for the improvement of the intersection of SE 45<sup>th</sup> Street and Croco Road as well as improvements to SE Croco Road from SE 39<sup>th</sup> Street to SE 44<sup>th</sup> Street as provided for in Trafficway Improvement Project No. 70203-00 as defined and described in Resolution No. 7785, adopted and approved on April 18, 2006.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF TOPEKA, KANSAS:

Section 1. For the purpose of paying the cost of pavement, curb and gutter and all other contingencies needed to complete the project, same being Trafficway Improvement Project No. 70203-00, in the City of Topeka, Shawnee County, Kansas, there is hereby levied and assessed a special assessment on all lots and pieces of ground liable therefore. Said assessments are computed as follows:

# A. <u>GENERAL NATURE OF IMPROVEMENT</u>:

This project provides for improvements to the intersection of SE 45<sup>th</sup> Street and SE Croco Road as well as improvements to SE Croco Road from SE 39<sup>th</sup> Street to SE 44<sup>th</sup> Street. Additionally, the intersection improvements include either a roundabout or a standard intersection with left turn lanes and traffic signals. Specially the project includes the design, construction, appraisal and acquisition of right-of-way and relocation of conflicting utilities necessary to improve this section of road from a 2-lane rural section to a multi-lane urban arterial with storm sewers and sidewalks.

## B. IMPROVEMENT DISTRICT:

A tract in Sections 22 and 23, Township 12 South, Range 16 east of the 6<sup>th</sup> P.M., in Shawnee County, Kansas, described as: Beginning at the Southeast corner of the Southeast Quarter of said Section 22; thence on an assumed bearing of North 89°52'00" West on the South line of said Southeast Quarter, 2643.81 feet to the Southwest corner of said Southeast Quarter; thence South 89°54'30" West on the South line of the East Half of the Southeast Quarter of the Southwest Quarter of said Section 22, 660.93 feet to the

Southwest corner of said East Half; thence North 00°11'08" West on the West line of said East Half, 1319.23 feet to the Northwest corner of said East Half; thence North 89°55'34" East on the North line of said East Half, 661.52 feet to the Northeast corner of said East Half; thence North 00°09'36" West on the West line of the Southeast Quarter of said Section 22, 185.85 feet; thence North 14°08'29" East on a West line of Rockfire at the Lake Subdivision, 588.22 feet; thence North 29°50'56" East on a West line of Rockfire at the Lake Subdivision, 179.74 feet; thence North 45°33'23" East on a Northwest line of Rockfire at the Lake Subdivision, 581.97 feet, to a point on the North line of the Southeast Quarter of said Section 22; thence North 89°56'57" East on the North line of the Southeast Quarter of said Section 22, to the Southwest corner of East Shawnee Lake Estates Subdivision; thence northerly on the West line of East Shawnee Lake Estates Subdivision to the Northwest corner thereof; thence easterly on the North line of the South Half of the Northeast Quarter of said Section 22, to the Northeast corner of the South Half of said Northeast Quarter: thence easterly on the North line of the South Half of the Northwest Quarter of said Section 23, to the Northeast corner of the South Half of said Northwest Quarter; thence southerly on the East line of the Northwest Quarter of said Section 23, to the Southeast corner of said Northwest Quarter: thence southerly on the East line of the Southwest Quarter of said Section 23, to the Southeast corner of said Southwest Quarter: thence westerly on the South line of the Southwest Quarter of said Section 23, to the point of beginning.

# C. <u>METHOD OF ASSESSMENT</u>:

On a square foot of area basis for all lots or individual dwelling or building sites which are included in the described improvement district.

## D. TOTAL COST & APPORTIONMENT OF COSTS:

FINAL PROJECT COST TO BENEFIT DISTRICT= \$966,277.95

<u>Section 2</u>. The several amounts are apportioned, levied and assessed against each of said lots and pieces of ground according to the benefits to be derived by reason of the aforesaid improvements, (except the interest hereinafter mentioned) as follows:

Section 3. Such assessments with accrued interest are hereby levied concurrent with general property taxes and shall be payable in twenty (20) equal annual installments; the first installment to be payable at the time of the first payment of the general property taxes, following the publication of this Ordinance.

425 <u>Section 4</u>. All assessments shall bear interest in an amount not to exceed the 426 legal rate established by law.

Section 5. The owner of any property so assessed may at any time prior to 30
days from the date of publication of this Ordinance, pay the whole of the assessment
against any lot or parcel with interest accrued to the date of payment, to the City Treasurer.
Section 6. Assessments not paid prior to the date provided in Section 5 hereof,
shall be certified, together with interest accrued, or to accrue, by the City Clerk to the
County Clerk, and collected in the same manner as other taxes.
Section 7. This Ordinance shall take effect and be in force from and after its
passage, approval and publication in the official city newspaper.
