15	(a) The Manual on Uniform Traffic Control Devices for Streets and Highways,
16	20032009 Edition, hereinafter referred to as "MUTCD," approved by the Federal
17	Highway Administrator as the National Standard in accordance with Title 23, U.S. Code,
18	Sections 109(d), 114(a), 217, 315 and 402(a), 23 CFR 655 and 49 CFR 1.48(b)(8),
19	1.48(b)(33), and 1.48(c)(2), is adopted by reference and made a part of this title as if
20	fully set out in this section; provided, however, that the lawful or designated authority
21	empowered to make changes in sign sizes or other deviations as set forth in the manual
22	shall be the city traffic engineer.
23	(b) Not less than one copy of the MUTCD, and of the ordinance or ordinances
24	pertaining thereto, shall be filed with the city clerk and shall be open to inspection and
25	available to the public at all reasonable hours. The police department, municipal judge,
26	and all administrative departments of the city charged with the enforcement of such

29 <u>Section 2</u>. That original § 10.10.200 of The Code of the City of Topeka,
30 Kansas, is hereby specifically repealed.

- 31 <u>Section 3</u>. This ordinance shall take effect and be in force from and after its 32 passage, approval and publication in the official City newspaper.
- 33 <u>Section 4</u>. This ordinance shall supersede all ordinances, resolutions or rules,
- or portions thereof, which are in conflict with the provisions of this ordinance.
- 35 <u>Section 5</u>. Should any section, clause or phrase of this ordinance be declared 36 invalid by a court of competent jurisdiction, the same shall not affect the validity of this 37 ordinance as a whole, or any part thereof, other than the part so declared to be invalid.
