9 10	NOW THEREFORE, BE IT ORDAINED BY COUNCIL OF THE CITY OF TOPEKA		
11	KANSAS, that:		
12	Section 1.	Authorization is given to barricade a portion of SW 8 th Street between	
13	Kansas Avenue an	d Jackson Street between the hours of 2:00 p.m. and 11:00 p.m. for Top	
14	City Thursday Concert Series events to be held in the summer of 2012 on May 17, 24 and		
15	31; June 7, 14, 21 and 28; July 12, 19 and 26; and August 2, 9, 16, 23 and 30. Attendance		
16	to the celebrations is open to the public between these hours. The Director of Public Works		
17	shall determine to what extent the street will be barricaded.		
18	Section 2.	The barricaded portion of SW 8th Street between Kansas Avenue and	
19	Jackson Street sha	all be temporarily removed from the City's right-of-way for the special	
20	event to be held in the summer of 2012 on May 17, 24 and 31; June 7, 14, 21 and 28; July		
21	12, 19 and 26; and August 2, 9, 16, 23 and 30. Vendors holding the appropriate license		
22	from the State of Kansas to sell alcoholic liquor may in accordance with all applicable state		
23	laws and municipal ordinances sell alcoholic liquor in the specific area designated by the		
24	Division of Alcohol Beverage Control within the barricaded portion of SW 8 th Street between		
25	Kansas Avenue and Jackson Street between the hours of 2:00 p.m. and 11:00 p.m. for Top		
26	City Thursday Concert Series events to be held in the summer of 2012 on May 17, 24 and		
27	31; June 7, 14, 21 and 28; July 12, 19 and 26; and August 2, 9, 16, 23 and 30.		

28	Section 3. Event attendees may buy, possess and consume alcoholic beverages		
29	in the specific area designated by the Division of Alcohol Beverage Control within the		
30	barricaded portion of SW 8 th Street between Kansas Avenue and Jackson Street between		
31	the hours of 2:00 p.m. and 11:00 p.m. for Top City Thursday Concert Series events to be		
32	held in the summer of 2012 on May 17, 24 and 31; June 7, 14, 21 and 28; July 12, 19 and		
33	26; and August 2, 9, 16, 23 and 30.		
34	Section 4. The Top City Thursdays Concert Series is hereby approved by the		
35	governing body as a special event as required by K.S.A. 41-2645(e)(1) and K.S.A. 41-		
36	719(a)(2).		
37	Section 5. This Ordinance shall take effect and be in force after its passage,		
38	approval and publication in the official city newspaper.
