	BE IT ORDAINED BY THE COUNCIL OF THE CITY OF TOPEKA, KANSAS, that:		
12	Section 1. Authorization is given to barricade certain portions of NE Freeman		
13	Street, NE Rowley Street, NE Greeley Street and an east-west alley on the south side of		
14	the church hall between Seward Avenue and Greeley Street as designated on the map		
15	attached hereto as Exhibit A (the "Designated Barricaded Area") on June 2, 2012, between		
16	the hours of 3:00 p.m. and 11:00 p.m. and on June 3, 2012, between the hours of 10:00		
17	a.m. and 6:00 p.m. Attendance to the celebration is open to the public between these		
18	hours.		
19	Section 2. The Designated Barricaded Area shall be temporarily removed from		
20	the City's right-of-way for the special event to be held on June 2, 2012, between the hours		
21	of 3:00 p.m. and 11:00 p.m. and on June 3, 2012, between the hours of 10:00 a.m. and		
22	6:00 p.m Vendors holding the appropriate license from the State of Kansas to sell		
23	alcoholic liquor may in accordance with all applicable state laws and municipal ordinances		
24	sell alcoholic liquor in the specific area designated by the division of Alcohol Beverage		
25	Control within the Designated Barricaded Area on June 2, 2012, between the hours of 3:00		
26	p.m. and 11:00 p.m. and on June 3, 2012, between the hours of 10:00 a.m. and 6:00 p.m.		
27	Section 3. Event attendees may buy, possess and consume alcoholic beverages		
28	in the specific area designated by the division of Alcohol Beverage Control within the

29	Designated Barricaded Areas on June 2, 2012, between the hours of 3:00 p.m. and 11:00		
30	p.m. and on June 3, 2012, between the hours of 10:00 a.m. and 6:00 p.m.		
31	Section 4.	The Germanfest is hereby granted a temporary special event retailers	
32	permit to sell, offer, and serve cereal malt beverages for consumption on the premises		
33	pursuant to K.S.A. 41-2703, as amended.		
34	Section 5.	The Germanfest is hereby approved as a special event as required by	
35	K.S.A. 41-2645 as amended.		
36	Section 6.	This Ordinance shall take effect and be in force after its passage,	
37	approval and publication in the official city newspaper.
