3 **ORDINANCE NO. 19745**

5 AN ORDINANCE introduced by Councilmember John Alcala authorizing the sale,  
6 consumption and possession of alcoholic liquor as part of the 2012  
7 Fiesta Mexicana at specified locations and times for a special event  
8 pursuant to K.S.A. 41-719(a)(2) and K.S.A. 41-2645(e)(1).

10 BE IT ORDAINED BY THE COUNCIL OF THE CITY OF TOPEKA, KANSAS, that:

11 Section 1. Authorization is given to barricade a portion of Atchison Avenue  
12 between NE Chandler and NE Lake Streets and NE Chandler Street between Greeley  
13 Street and Atchison Avenue from July 10, 2012, through July 14, 2012, between the hours  
14 of 4:00 p.m. and 11:59 p.m. Attendance to the celebration is open to the public between  
15 these hours. Licensed retailers may sell non-alcoholic commodities or food from July 10,  
16 2012, and July 14, 2012, between the hours of 4:00 p.m. and 11:59 p.m.

17 Section 2. The barricaded portion of Atchison Avenue between Chandler and NE  
18 Lake Streets and NE Chandler Street between Greeley Street and Atchison Avenue shall  
19 be temporarily removed from the City's right-of-way for the special event to be held on July  
20 10, 2012 through July 14, 2012 between the hours of 4:00 p.m. and 11:59 p.m. Vendors  
21 holding the appropriate license from the State of Kansas to sell alcoholic liquor may in  
22 accordance with all applicable state laws and municipal ordinances sell alcoholic liquor in  
23 the specific area designated by the division of Alcohol Beverage Control within the  
24 barricaded portion of Atchison Avenue between Chandler and NE Lake Streets and NE  
25 Chandler Street between Greeley Street and Atchison Avenue from July 10, 2012 through  
26 July 14, 2012, between the hours of 4:00 p.m. and 11:59 p.m.

27 Section 3. Event attendees may buy, possess and consume alcoholic beverages  
28 in the specific area designated by the division of Alcohol Beverage Control within the

barricaded portion of Atchison Avenue between Chandler and NE Lake Streets and NE Chandler Street between Greeley Street and Atchison Avenue from July 10, 2012 through July 14, 2012, between the hours of 4:00 p.m. and 11:59 p.m.

Section 4. The Fiesta Mexicana is hereby granted a temporary special event retailers permit to sell, offer, and serve cereal malt beverages for consumption on the premises pursuant to K.S.A. 41-2703, as amended.

Section 5. The Fiesta Mexicana is hereby approved as a special event as required by K.S.A. 41-2645(e)(1) and K.S.A. 41-719(a)(2).

Section 6. This Ordinance shall take effect and be in force after its passage, approval and publication in the official city newspaper.
