13	Avenue and Jackso	on Street on September 7, 2012, from 9:00 p.m. to 11:59 p.m., and then	
14	on September 8, 2012, beginning at 3:00 p.m. and ending at 1:30 a.m. on September 9,		
15	2012, for the Brews, BBQ and Blues Fest. Attendance to the celebration is open to the		
16	public between these hours.		
17	Section 2.	The barricaded portion of SW 8th Street shall be temporarily removed	
18	from the City's righ	t-of-way in accordance with TMC 9.15.020(a) for a special event to be	
19	held on September 7, 2012, from 9:00 p.m. to 11:59 p.m., and then on September 8, 2012,		
20	beginning at 3:00 p.m. and ending at 1:30 a.m. on September 9, 2012, on SW 8 th Street		
21	between Kansas Avenue and Jackson Street. Vendors holding the appropriate license		
22	from the State of Kansas to sell alcoholic liquor may in accordance with all applicable state		
23	laws and municipal ordinances sell alcoholic liquor in the specific area designated by the		
24	Division of Alcohol Beverage Control within the barricaded portion of SW 8 th Street between		
25	Kansas Avenue and Jackson Street on September 7, 2012, from 9:00 p.m. to 11:59 p.m.,		
26	and then on September 8, 2012, beginning at 3:00 p.m. and ending at 1:30 a.m. on		
27	September 9, 2012.

28	Section 3. Event attendees may buy, possess and consume alcoholic beverages		
29	in the specific area designated by the Division of Alcohol Beverage Control within the		
30	barricaded portion of SW 8 th Street between Kansas Avenue and Jackson Street on		
31	September 7, 2012, from 9:00 p.m. to 11:59 p.m., and then on September 8, 2012,		
32	beginning at 3:00 p.m. and ending at 1:30 a.m. on September 9, 2012.

34	body as a special event as required by K.S.A. 41-2645(e)(1) and K.S.A. 41-719(a)(2).
