4 5 6 7	AN ORDINANCE introduced by Councilmember Chad Manspeaker, amending City of Topeka Code § 3.25.100, concerning the historic asset tourism fund and specifically repealing said original section.
8 9	BE IT ORDAINED BY THE COUNCIL OF THE CITY OF TOPEKA, KANSAS:
10 11	Section 1. That section 3.25.100, Historic asset tourism fund, of The Code of
12	the City of Topeka, Kansas, is hereby amended to read as follows:
13	Historic asset tourism preservation fund.
14	(a) There is hereby created in the city a special fund to be known as the
15	historic asset tourismpreservation fund. Moneys from the city's general fund,
16	community block grant funds, any transient guest tax funds allocated to this fund, or
17	funds from any other source legally available for such purpose shall be credited to this
18	special f und.
19	(b) Moneys deposited into this fund shall be expended only on projects of a
20	public heritage tourism benefit located within the city and shall not be expended on
21	projects that are private or primarily commercial in nature, unless open or intended to be
22	open to the public on a regularly scheduled basis that facilitate tourism resulting from
23	the preservation and promotion of the City's historical assets, including but not limited
24	to:
25	(1) Restoring and preserving sites listed on a local, state or national
26	register of historic sites that are not private or primarily commercial in nature
27	unless open or intended to be open to the public on a regularly scheduled basis.
28	(2) Marketing the City's historical assets.

29	(3) Providing financial commitments associated with securing grant
30	funding from government or private sources.
31	Disbursement of funds for projects identified in subsections (b)(2) and (3)
32	shall not exceed fifteen percent (15%) of the total amount of historic preservation
33	funds allocated for each calendar year.
34	(c) Projects funded by these funds shall be subject to the review and
35	recommendations of the historic sites for heritage tourism committee (The historic
36	tourism committee) consistingshall:
37	(1) Make recommendations to the transient guest tax committee which
38	shall determine whether to approve disbursement of transient guest tax funds for
39	projects identified in subsection (b).
40	(2) Make recommendations to the city manager who shall determine
41	whether to approve disbursement of funds, other than transient guest tax funds,
42	credited to the historic preservation fund for projects identified in subsection (b).
43	(3) Establish bylaws and guidelines for grant applications, subject to
44	review and approval by the transient guest tax committee.
45	(d) The historic tourism committee shall consist of the following members:
46	(a1) TwoAll members of the landmarks commission;
47	(b2) TwoOne members of the Topeka tourism alliance selected by the
48	transient guest tax committee;
49	(e3) TwoOne members of the Topeka and Shawnee County area
50	"Freedom's Frontier" heritage tourism alliance selected by the transient guest tax
51	<u>committee</u> ; and

52	(d 4)	One memberThe	president	or (<u>designee</u>	of	the	Topeka	lodging

The individuals selected by the transient quest tax committee shall serve for as long as each is a member of the respective organization identified in subsection (d) or until removed by the transient guest tax committee. The chairperson of the landmarks commission shall chair the historic tourism committee which shall meet at the call of the chairperson.

Bylaws for the historic tourism committee, as well as guidelines for grant application and the grant application form, will be established and may be amended by the historic tourism committee, subject to approval by the city council transient quest tax committee.

The expenditure recommendations of the historic tourism committee, for disbursement of transient quest tax moneys from this fund, shall be forwarded to the city council transient quest tax committee for final approval of the expenditures. The expenditure recommendations of the historic tourism committee, for disbursement of moneys from this fund that are from sources other than transient guest tax, shall be forwarded to the city manager for final approval of the expenditure.

- That original § 3.25.100 of The Code of the City of Topeka, Kansas, Section 2. is hereby specifically repealed.
- This ordinance shall take effect and be in force from and after its Section 3. passage, approval and publication in the official City newspaper.
