That section 10.15.010, Incorporation of Standard Traffic 12 Ordinance, of The Code of the City of Topeka, Kansas, is hereby amended to read as 13 follows:

Incorporation of Standard Traffic Ordinance.

15 (a) Generally – Copies. There is hereby incorporated by reference for the purpose of regulating traffic within the corporate limits of the city of Topeka, Kansas, the 16 17 Standard Traffic Ordinance for Kansas Cities, Edition of 20112012, prepared and 18 published in book form by the League of Kansas Municipalities, Topeka, Kansas, save 19 and except such articles, sections or parts or portions as are hereafter omitted, deleted, 20 modified or changed. No fewer than three copies of the Standard Traffic Ordinance shall 21 be marked or stamped "Official Copy as Adopted by Ordinance No. 19652 19774," with 22 all sections or portions thereof intended to be omitted or changed clearly marked to 23 show any such omission or change and to which shall be attached a copy of the ordinance codified in this chapter and filed with the city clerk to be open to inspection 24 25 and available to the public at all reasonable hours. The police department, municipal 26 judge and all administrative departments of the city charged with enforcement of the ordinance shall be supplied, at the cost of the city, such number of official copies of the 27 28 Standard Traffic Ordinance similarly marked, as may be deemed expedient.

29 (b) Traffic Infractions and Traffic Offenses.

30 (1) A traffic infraction is a violation of any section of this title or of the 31 Standard Traffic Ordinance that prohibits or requires the same behavior as that 32 prohibited or required by a statutory provision that is classified as a traffic 33 infraction in K.S.A. 8-2118, and amendments thereto.

34 (2) All traffic violations which are included within this title and which are
 35 not traffic infractions as defined in subsection (b)(1) of this section shall be
 36 considered traffic offenses.

37 <u>Section 2</u>. That original § 10.15.010 of The Code of the City of Topeka,
 38 Kansas, is hereby specifically repealed.

39 <u>Section 3</u>. This ordinance shall take effect and be in force from and after its
 40 passage, approval and publication in the official City newspaper.

41 <u>Section 4</u>. This ordinance shall supersede all ordinances, resolutions or rules,
42 or portions thereof, which are in conflict with the provisions of this ordinance.

43 <u>Section 5</u>. Should any section, clause or phrase of this ordinance be declared 44 invalid by a court of competent jurisdiction, the same shall not affect the validity of this 45 ordinance as a whole, or any part thereof, other than the part so declared to be invalid.
