**ORDINANCE NO. 19779**

AN ORDINANCE introduced by Deputy Mayor Larry Wolgast concerning the reestablishment of the City Council district boundaries, pursuant to the provisions of Section A2-23(c) of the Code of the City of Topeka, and specifically repealing City of Topeka Ordinance No. 17920.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF TOPEKA, KANSAS, that:

Section 1.

*Council districts.* The districts from which the City of Topeka Council members shall be nominated shall be based on the ward and precinct descriptions as follows, effective January 1, 2013:

Section 2. The Council of the City of Topeka hereby certifies the boundaries as re-established and directs the City Clerk to cause a certified copy of this Ordinance to be delivered to the election commission of Shawnee County.

Section 3. The City of Topeka Ordinance No. 17920 is hereby specifically repealed.

Section 4. This Ordinance shall take effect and be in force from and after its passage, approval and publication in the official city newspaper.

Section 5. This ordinance shall supersede all ordinances, resolutions or rules, or portions thereof, which are in conflict with the provisions of this ordinance.

Section 6. Should any section, clause or phrase of this ordinance be declared invalid by a court of competent jurisdiction, the same shall not affect the validity of this ordinance as a whole, or any part thereof, other than the part so declared to be invalid.
