ORDINANCE NO. 19813

AN ORDINANCE introduced by Councilmember John Campos authorizing the sale, consumption and possession of alcoholic liquor at specified locations and times for the 2013 Germanfest celebration on June 1 and 2 to be held at Sacred Heart-St. Joseph Parish.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF TOPEKA, KANSAS, that:

Section 1. Authorization is given to barricade certain portions of NE Freeman Street, NE Rowley Street, NE Greeley Street and an east-west alley on the south side of the church hall between Seward Avenue and Greeley Street as designated on the map attached hereto as Exhibit A (the "Designated Barricaded Area") on June 1, 2013, between the hours of 3:00 p.m. and 11:00 p.m. and on June 2, 2013, between the hours of 10:00 a.m. and 6:00 p.m. Attendance to the celebration is open to the public between these hours.

Section 2. The Designated Barricaded Area shall be temporarily removed from the City's right-of-way for the special event to be held on June 1, 2013, between the hours of 3:00 p.m. and 11:00 p.m. and on June 2, 2013, between the hours of 10:00 a.m. and 6:00 p.m. Vendors holding the appropriate license from the State of Kansas to sell alcoholic liquor may in accordance with all applicable state laws and municipal ordinances sell alcoholic liquor in the specific area designated by the division of Alcohol Beverage Control within the Designated Barricaded Area on June 1, 2013, between the hours of 3:00 p.m. and 11:00 p.m. and on June 2, 2013, between the hours of 10:00 a.m. and 6:00 p.m.

<u>Section 3.</u> Event attendees may buy, possess and consume alcoholic beverages in the specific area designated by the division of Alcohol Beverage Control within the Designated Barricaded Areas on June 1, 2013, between the hours of 3:00 p.m. and 11:00 p.m. and on June 2, 2013, between the hours of 10:00 a.m. and 6:00 p.m.

<u>Section 4</u>. The Germanfest is hereby granted a temporary special event retailers permit to sell, offer, and serve cereal malt beverages for consumption on the premises pursuant to K.S.A. 41-2703, as amended.

<u>Section 5</u>. The Germanfest is hereby approved as a special event as required by K.S.A. 41-2645(e)(1) and K.S.A. 41-719(a)(2), as amended.

<u>Section 6</u>. This Ordinance shall take effect and be in force after its passage, approval and publication in the official city newspaper.
