ORDINANCE NO. 19833

AN ORDINANCE introduced by Jim Colson, City Manager, apportioning and levying a special assessment on certain lots and pieces of ground in the City of Topeka, Shawnee County, Kansas, in the area of John Norton's Addition for Sanitary Sewer Improvement Project No. T-401027.00, as defined and described in Resolution No. 8329, adopted and approved May 3, 2011.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF TOPEKA, KANSAS:

Section 1. For the purpose of paying the cost Sanitary Sewer Improvement Project No. T-401027.00, in the City of Topeka, Shawnee County, Kansas, the Governing Body, pursuant to K.S.A. 12-6a01 *et seq.*, hereby levies and assesses a special assessment on all lots and pieces of ground liable therefore. Said assessments are computed as follows:

A. GENERAL NATURE OF IMPROVEMENT:

This project will provide sanitary sewer to the house located at 1148 SW Jewell Avenue. The project will include a connection to the existing system, standard manholes, eight inch sewer pipe, trench and backfill, sidewalk replacement, alley replacement and other related appurtenances needed for a complete project.

B. IMPROVEMENT DISTRICT:

The South 2.97 feet of Lot 420, except the East 49 feet thereof, Lots 422 and 424, except the East 49 feet thereof, Jewell Avenue, formerly Brooks Avenue, in John Norton's Addition to the City of Topeka, Shawnee County, Kansas.

C. METHOD OF ASSESSMENT:

On a unit basis for all lots or individual dwelling sites which are included in the described improvement district. (1 unit)

D. TOTAL COST & APPORTIONMENT OF COSTS:

FINAL PROJECT COST = ~~\$22,186.23~~ \$18,186.23

Section 3. Such assessments with accrued interest are hereby levied concurrent with general property taxes and shall be payable in twenty (20) equal annual installments; the first installment to be payable at the time of the first payment of the general property taxes, following the publication of this ordinance.

Section 4. All assessments shall bear interest in an amount not to exceed the legal rate established by law.

Section 5. The owner of any property so assessed may at any time prior to 30 days from the date of publication of this ordinance, pay the whole of the assessment against any lot or parcel with interest accrued to the date of payment, to the City Treasurer.

Section 6. Assessments not paid prior to the date provided in Section 5 hereof, shall be certified, together with interest accrued, or to accrue, by the City Clerk to the County Clerk, and collected in the same manner as other taxes.

Section 7. This ordinance shall take effect and be in force from and after its passage, approval and publication in the official city newspaper.
