23	WHEREAS, the City is a municipality as defined by K.S.A. 10-101 et seq. and 10-

25	WHEREAS, the City is authorized by the laws of the State of Kansas to issue and		
26	sell revenue bonds of the City for the improvement of its water, water pollution control, and		
27	stormwater utility system (the "System") pursuant to K.S.A. 10-1201 et seq. and all

29	WHEREAS, it is deemed by the Governing Body of the City to be necessary and		
30	advisable that the City to improve its System by constructing a water main extension from

43 WHEREAS, the City desires to issue and sell revenue bonds and/or general 44 obligation bonds of the City and/or to borrow funds from the KDHE SRF Loan to fund the 45 cost of the improvements or any combination thereof.

46 NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF47 TOPEKA, KANSAS:

48 <u>Section 1</u>. That the estimates of costs of the Project as contained in the project
49 budget, in the total amount of two million six hundred seventy thousand dollars
50 (\$2,670,000.00) which are set out on the project budget attached hereto and on file in the
51 office of the City Clerk of said City, be and the same are hereby approved.

52 <u>Section 2</u>. This project consists of installing about 5300-ft of 18-inch and 2800-ft 53 of 24-inch water main to provide a critical redundancy transmission main, or loop, from the 54 Fairlawn Booster Pump Station (BPS) servicing the Indian Hills and Sherwood elevated 55 storage tanks, also known as the West Pressure Zone. This project is essential for 56 providing adequate fire protection and water service to existing residential and lucrative 57 commercial development along SW Wanamaker Rd and intersecting arterials. This service area is located generally west of the I-470 corridor and north of SW 45th Street to
Kansas River. This main will also afford critical water main support and pressure zone
realignment for future City development and expansion to the Kanza Fire Commerce Park
area for long-term growth capacity in south and west Topeka in accordance with Water
Distribution System Master Plan (2002).

63 Section 3. That notice be given by the Governing Body of the City of its intention 64 to complete the Project in accordance with the plans, specifications and cost estimates and 65 use utility operation funds, and/or to sell revenue bonds and/or general obligation bonds of 66 the City and/or to borrow funds from the KDHE SRF Loan in a total amount not exceeding 67 two million six hundred seventy thousand dollars (\$2,670,000.00) to pay the cost thereof. 68 Such notice shall be signed by the Mayor and attested by the City Clerk and shall be 69 published in the official City newspaper. Such notice shall describe the nature of the 70 proposed improvements and shall state the amount of revenue and/or general obligation 71 bonds proposed to be issued and/or loan funds to be borrowed, or any combination thereof 72 for the payment of the cost of the project and otherwise, the notice shall be in the form as 73 provided by law.

Section 4. That unless written protests against such proposed improvements signed by not less than twenty percent (20%) of the qualified electors of the City are filed with the City Clerk within fifteen (15) days after publication of the notice herein authorized the City both reasonably expects and intends to finance the costs as hereinbefore described from the proceeds of revenue bonds and/or general obligation bonds and/or loan funds or any combination thereof, payable from the rates, fees and charges of the System. The City does hereby express its official intent to reimburse any expenditures made in
