<u>Section 3</u>. Such assessments with accrued interest are hereby levied concurrent with general property taxes and shall be payable in twenty (20) equal annual installments; the first installment to be payable at the time of the first payment of the general property taxes, following the publication of this Ordinance.

Section 4. All assessments shall bear interest in an amount not to exceed the legal rate established by law.

Section 5. The owner of any property so assessed may at any time prior to 30 days from the date of publication of this Ordinance, pay a portion or the entire amount of the assessment against any lot or parcel, to the City Treasurer.

72	Section 6. Assessment amounts not paid prior to the date provided in Section 5
73	hereof, shall be certified by the City Clerk to the County Clerk. The assessments with
74	accrued interest shall be levied as a special tax upon the property as prescribed in K.S.A.
75	12-6A10 and amendments thereto.
76	Section 7. This Ordinance shall take effect and be in force from and after its
77	passage, approval and publication in the official city newspaper.
