ORDINANCE NO. 19988

AN ORDINANCE introduced by City Manager Jim Colson, amending City of Topeka Code Section 9.05.080, concerning adoption of the 2015 Uniform Public Offense Code and specifically repealing said original section.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF TOPEKA, KANSAS:

Section 1. That section 9.05.080, of The Code of the City of Topeka, Kansas, is hereby amended to read as follows:

Uniform Public Offense Code.

(a) Adoption. There is hereby incorporated by reference for the purpose of regulating public offenses within the corporate limits of the city of Topeka, Kansas, the Uniform Public Offense Code for Kansas Cities, ~~29th~~ 31st Edition (~~2013~~2015), prepared and published in book form by the League of Kansas Municipalities, Topeka, Kansas, (hereinafter referred to as “UPOC ~~2013~~2015”) except for ~~10.1.1(a)(5) (“Transporting firearms”),~~ 10.24 (“Smoking Prohibited”), 10.25 (“Smoking; Posting Premises”), 10.26 (“Smoking Prohibited; Penalties”) and 11.11 (“Cruelty to Animals”), which are specifically deleted and omitted. ~~No fewer than three copies~~ One copy of said Uniform Public Offense Code shall be marked or stamped “Official Copy as adopted by Ordinance No. ~~49880-19988~~,” with all sections or portions thereof intended to be omitted or changed clearly marked to show any such omission or change and to which shall be attached a copy of said ordinance and filed with the city clerk to be open to inspection and available to the public at all reasonable hours.

(b) Amendments.

(1) Section 10.6 of UPOC ~~2013~~2015, relating to bows and arrows, is

hereby amended by adding the following exception:

Exception: Operation of a bow and arrow is permitted in accordance with the provisions set forth in TMC 6.05.070.

~~(2) Section 10.4(a) of UPOC 2013, relating to confiscation of weapons, is deleted and the following shall be substituted:~~

~~(a) Upon conviction for any violation described in Sections 10.1, 10.1.1, 10.2, 10.3, 10.3.1, and 10.5 of this article, any weapon seized in connection therewith shall remain in the custody of the trial court.~~

Section 2. That original § 9.05.080 of The Code of the City of Topeka, Kansas, is hereby specifically repealed.

Section 3. This ordinance shall take effect and be in force from and after its passage, approval and publication in the official City newspaper.

Section 4. This ordinance shall supersede all ordinances, resolutions or rules, or portions thereof, which are in conflict with the provisions of this ordinance.

Section 5. Should any section, clause or phrase of this ordinance be declared invalid by a court of competent jurisdiction, the same shall not affect the validity of this ordinance as a whole, or any part thereof, other than the part so declared to be invalid.
