9 10	BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF TOPEKA, KANSAS:				
11	Section 1. That section 2.50.010, Created, of The Code of the City of Topeka,				
12	Kansas, is hereby amended to read as follows:				
13	Created.				
14	There is hereby created a building code enforcement division. This division shall				
15	be under the general supervision of the public worksplanning director and as such shall				
16	be an administrative division within the public worksplanning department				
17	Section 2. That section 2.50.040, Powers and duties generally, of The Code of				
18	the City of Topeka, Kansas, is hereby amended to read as follows:				
19	Powers and duties generally.				
20	(a) The director of development services shall be the superintending head of				
21	the building code enforcement division and shall be responsible for the performance of				
22	the duties of the subordinate members and employees of the division. The director of				
23	development services shall be authorized and empowered to perform the duties				
24	imposed upon any inspector or assistant inspector of the building code enforcement				
25	division, any ordinance of the city to the contrary notwithstanding. In the discharge of				
26	duties, the director of development services shall be directly responsible to the public				
27	worksplanning director and shall make such reports of the affairs of the building code				
28	enforcement division as may be required by the public worksplanning director.				

	(b)	The director of development services shall have such other duties as may					
be co	nferred	upon the directorimposed by the further provisions of this chapter and					
other ordinances of the city imposing special duties upon the building code enforcement							
divisio	n.						

<u>Section 3</u>. That section 2.50.050, Appointment of subordinate officers and employees, of The Code of the City of Topeka, Kansas, is hereby repealed.

Appointment of subordinate officers and employees.

The code enforcement director may appoint such number of inspectors, assistant inspectors, clerks, stenographers and such other employees of the code enforcement division as are necessary for the operation thereof. All such inspectors, assistants and other employees may be removed as provided by applicable law.

<u>Section 4</u>. That section 2.50.060, Expert technical advisors, of The Code of the City of Topeka, Kansas, is hereby amended to read as follows:

Expert technical advisors.

The code enforcement director shall be authorized, subject to the approval of the public worksplanning director, to employutilize expert technical advisors when deemed necessary to determine any question arising under the ordinances of the city-relating to the duties of the building code enforcement division.

- Section 5. That original § § 2.51.010, 2.50.040 and 2.50.060 of The Code of the City of Topeka, Kansas, are hereby specifically repealed.
- <u>Section 6</u>. This ordinance shall take effect and be in force from and after its passage, approval and publication in the official City newspaper.
- <u>Section 7</u>. This ordinance shall supersede all ordinances, resolutions or rules, or portions thereof, which are in conflict with the provisions of this ordinance.

inva	invalid by a court of competent jurisdiction, the same shall not affect the validity of this
